WHAT IS THE CORPORATE CUP CHALLENGE?

The Corporate Cup features 6 events where Salina Area businesses, government agencies, and other organizations will compete for the annual corporate cup. Each company will be given an event roster with a set number of teams per each event. Each event will be scored allowing teams to accumulate points. The team with the most points will win the Corporate Cup.

PROCEEDS

All proceeds generated from the Corporate Cup will support the YMCA's annual campaign. The YMCA Annual Campaign plays a crucial role in expanding opportunities and access to those in our community who need it most. This year the Y is working hard to increase our impact by expanding teen programming to serve our most vulnerable youth. Corporate Cup participants who join the Salina Family YMCA in the month of July will get their first month FREE.

COMPANY ELIGIBILITY

1. All employees 18 and older can participate.
2. Team members must be employed by the registered company apart from the 5K run. Employment is defined as full-time or part-time.
3. Two Companies within the Small and Mini divisions may combine to form one team as long as their “unlimited roster” stays within 30 members. As an example, if company A has 10 employees and Company B has 8 employees, they may join to compete.
4. Participants must complete all necessary forms, including the Employee Participation Form and Liability Waivers for each employee.
5. Participants can only compete for one company team.
6. The Salina Family YMCA reserves the right to review all team entries relative to eligibility.
7. There are no restrictions on how many events an individual may do.
8. The company coordinator must complete the following forms: Employer Information and Participant Form and the Corporate Cup Event Roster Form by the registration deadline.
9. The participant must complete the Employee Participation and Liability Waiver Form.

DIVISIONAL PARTICIPATION COST

The participation cost depends on your company’s size. Each division has their own specific roster sizes. The cost associated with each division is listed below:

SCORING SYSTEM

Placement	Points
1st	60 Points
2nd	55 Points
3rd	50 Points
4th	45 Points
5th	40 Points
6th	35 Points
7th	30 Points
8th	25 Points
9th	20 Points
10th	10 Points

Maximum Points Per Event:

The maximum number of points a team can win in each event is 100: 60 points for first place plus 40 points for participation. (The 5K Run/Walk is an exception to this rule. Details on pg. 9.) If a company has multiple teams that score in the top 10, the highest placing team will receive the points.

Example: As an example, if my company is in 3rd and 9th place, the 3rd place score 50 points will be combined to the participation score. This will help keep it an even playing field for all participating companies. Placement points will be added to participation points.

Participation Points:

Participation points depend on how many teams you produce for each event. If I produce all the teams required for the given event based on company size, I will get 30 points. If I do not produce all the given teams in that event’s roster, points will be deducted from 30. If I produce 3 out of 4 teams, then $.75 \times 30 = 22.5$ participation points for that event. This will be added to that event’s score.

Volunteers:

You also get one point for every volunteer you produce. This will be added to your final score at the end of the games.

EVENTS

The event descriptions outline the number of player’s permissible, gender make-up and maximum/minimum number of teams. In the case the minimum number of team’s criteria is not met, team captains will be notified, and that event will be cancelled. The following events will be offered:

- A. Pickleball
- B. Kickball
- C. 3v3 Basketball
- D. Sand Volleyball
- E. Cornhole
- F. 5k Walk/Run

PICKLEBALL (COED)

Date: Saturday, June 28 | **Location:** Oakdale Park (730 Oakdale Dr, Salina, KS 67401) | **Time:** 9:00am

General Information/Game Rules

- Pickleball will be a Coed doubles event.
- Each company is allowed their own number of teams based on divisional size. (pg. 5)
- This event will be double elimination bracket play.
- Teams will be placed 1-10 receiving points.
- A match will consist of the best two out of three sets. Each set will be played to 11, win by 2.
- Only one team is required for the corporation to participate.
- Rules of the game will be found in the Corporate Cup Challenge 2025 Rulebook on our website.
- Matches will start Saturday morning at 9:00am and continue through the full day.
- In the case of poor weather, the tournament will be moved to an indoor location.



KICKBALL (COED)

Date: Saturday, July 12 | **Location:** Salina Family YMCA (570 YMCA Dr, Salina, KS) | **Time:** 9:00am

General Information/Game Rules

- Kickball will be Coed, double elimination.
- There will be 5 innings in each game.
- Teams may have up to 11 players (6 men, 5 women) or (5 men, 6 women). Teams only need 8 players to participate (4 men, 4 women).
- Batting order must rotate between a man and a woman.
- 8 will play the field but all 11 will be able to hit in the lineup as Extra Kickers (EK).
- Each organization is allowed to have one team.
- No additional alternatives will be allowed after tournament play has begun.
- If team members show up after the game has already started, they may still be able to play but they must hit last in the kicking order.
- All games will be played according to the YMCA Corporate Cup Challenge Rulebook found on our website.
- All kickballs will be provided.
- There will be a coin flip before every game to determine home and away teams.
- In the event of a tie, the following inning (6th) will have a runner on second with no outs. The next inning (7th) will have a runner on second with 1 out. The (8th) inning will have a runner on second with 2 outs. If the game goes into the (9th) inning, bases are loaded with 2 outs.

3V3 BASKETBALL

Date: Saturday, July 19 | **Location:** Salina Family YMCA (570 YMCA Dr, Salina, KS) | **Time:** TBA

General Information/Game Rules

- 3v3 basketball will have two divisions (Men's and Women's).
- Each company is allowed a certain number of teams based on company size. (pg. 5)
- This event will be double elimination bracket play.
- Games will be two 5-minute halves.
- Each team may have a roster of up to 4 but at least 3 to participate in the tournament.
- Specific in game rules will be found in the YMCA Corporate Cup Challenge 2025 Rulebook found on our website.
- Points inside of the 3-point line will be 1 point. Points beyond the 3-point line will be 2 points.
- Only one team is required to play for the corporation to participate.

SAND VOLLEYBALL (COED)

Date: Saturday, July 26 | **Location:** Webster Conference Center (2601 N Ohio St, Salina, KS) | **Time:** 9:00am

General Information/Game Rules

- Sand Volleyball will be a Coed double elimination tournament.
- The team must consist of 8 participants (4 men, 4 women). A team not meeting the qualifications will forfeit. (6 to play).
- Each organization has their own set of teams, based on company size. (pg. 5)
- No additional alternatives will be allowed after the tournament play has begun.
- Teams are expected to cooperate with match referees, game umpires and event judges. Only the event captain may dispute a call.
- After each point, participants must rotate clockwise. This rotation will be enforced by the referee.
- Rally scoring will be used.
- A match will consist of the best two of three sets. Each set will be played to 15, win by 2.
- Blocking the serve is not allowed.
- There will be one timeout allowed per team, per game. Timeouts will last a maximum of 30 seconds.
- After each set, teams will switch sides. The next set will resume 2 minutes after the previous set.
- All rules for this event will be in the YMCA Corporate Cup Challenge 2025 Rulebook.



CORNHOLE (COED)

Date: Saturday, August 2 | **Location:** Salina Family YMCA (570 YMCA Dr, Salina, KS) | **Time:** TBA

General Information/Game Rules

- Cornhole will be a Coed, double elimination tournament.
- Each company is allowed a different number of teams, based on company size. (pg. 5)
- Only one team is required for the company to compete in the event.
- All scoring and game rules will be provided in the YMCA Corporate Cup Challenge 2025 Rulebook.

5K RUN/WALK

Date: Saturday, August 9 | **Location:** Salina Family YMCA (570 YMCA Dr, Salina, KS) | **Time:** 8:00am



General Information/Game Rules

This event is scored based on participation. 5 points will be awarded to every participant, including family members. Participation maxes out at 100 points (or 20 participants). The first 5 finishers of the race can earn extra points for their company. Points will be awarded to each company based on placement. The placement points will be added to the participation points. (See chart below.) If multiple members of your company score in the top 5, their points will be counted to the total.

ADDITIONAL INFORMATION

Communication: The Salina Family YMCA will communicate exclusively through the company coordinator. Employees should direct all questions concerning the Salina Family YMCA Corporate Cup to their company coordinator.

Schedule of Events Booklet: Company coordinators will receive the updated Corporate Cup Event schedule on June 23. Event times may be approximate and can vary slightly due to weather and/or unanticipated delays in the event schedule.

Rescheduling of Games: In the event of inclement weather and unpredictable circumstances, every attempt will be made to reschedule any competition that may be affected.

No Forfeits Please: Once you receive your Corporate Cup Events Booklet, please make sure participants in each event are notified of the game times and location. A forfeit not only upsets the scheduled event but also takes away from the spirit and competition of the games. Please emphasize to your employees that by signing up for an event, they are making a commitment to be there. Not showing up for an event shall be counted as a loss or elimination with a deduction of 5 points per team entered.

IMPORTANT: ROSTER INFORMATION

Your company's roster must be completed and sent to the Y by May 7. The roster will be a **shared** Google doc that you can **share** with your employees. Our recommendation is that you choose an individual to get employee interest and fill out the roster for the entire company. Whether you fill out the roster on Google docs, or decide to print, it must be returned to the YMCA by March 7.
